OBJECTIVES

In order to promote and disseminate research work, COLPARMEX announces the International Award for Research Work in Administrative Sciences, a contest where research work in the areas of Accounting, Administration and Administrative Informatics will participate, under the following:

BASES

I. OF THE PARTICIPANTS:

All researchers, academics, students and professionals with postgraduate studies in Accounting, Administration, Administrative Informatics or related areas of nationality other than Mexican may participate.

II. OF WORKS:

The works must meet the following requirements:

1.- Be a research work to be seen on topics related to the areas of Accounting, Administration and Administrative Informatics or areas related to administration;

2.- Send the relative files in Word and PDF format to the email [congresocolpamex@hotmail.com](mailto:congresocolpamex@hotmail.com) in full, using the APA format (seventh edition of the Style Manual of the American Psychological Association) considering:

a) That the first two files (one in Word and the other in PDF) have the entire work and the author's identification data considering:

- Name of the researcher;
- Address;
- Telephone;
- Email;
- Institution of origin (if applicable);
- Name of advisor (if any), and;
- Any other information that facilitates your identification.

b) The other two files (one in word and the other in PDF), must have both a cover page with the name of the work and the selected pseudonym.

3.- Papers must be written in Spanish, English or French, with a maximum length of three hundred pages and following a methodology appropriate to the topic.

The source programs will be accompanied, if that were the case.

4.- For the evaluation of each of the works, the following considerations will be taken into account:

- Nature of the investigation;
- Application of a rigorous research methodology;
- Contribution and innovation of criteria;
- The applicability;
- The depth of the investigation.

5.- The works will be evaluated through a triple blind process.

6.- The deadline for receipt is August 31, 2021.

Any work not submitted within the terms will be considered as not submitted.

7.- The works that do not comply with any of the previous paragraphs, will be declared as non-participant.

8.- The results will be reported to the COLPARMEX Board of Directors and will be reported within the framework of the International Congress.

9.- Only works that have not been awarded in advance in other international forums may participate.

10.- Each work may have a maximum of three authors.

11.- By submitting their work, the authors accept the conditions relating to this call.

### III. OF THE PUBLICATION:

COLPARMEX reserves the right to publish the works received using the means it deems pertinent.

### IV. THE JUDGE:

The Qualifying Jury will be made up of prominent members of COLPARMEX and prestigious institutions.

The aforementioned Jury will decide what is conducive in the situations that arise and are not considered in this call. Its ruling will be final.

COLPARMEX reserves the right to declare the award void if there are no works that deserve the award.
